# Management Commentary

- No change to revenue outlook for FY2015
- Growth convergence across verticals
- Major markets continue to grow in-line, APAC and India expected to grow faster
- Inorganic revenues of \$100M in 2Q on account of consolidation impact of Japan merger
- Currency impact due to Rupee movement; +10 bps CC to INR revenue; -80 bps CC to USD revenues ; no impact on EBIT Margin
- Target EBIT Margin band unchanged; Japan consolidation impact offsets previous quarter depreciation impact
- Dividend distribution ~₹ 15,000 crore in 2Q impacts Other Income by ~₹ 300 crore
